TERMS OF REFERENCE

Part Time National Consultant to revise and Improve the Productivities Master Plan

1. Background

The Government of Lao PDR received financing from the World Bank Group's International Development Association (IDA) for a proposed project to assist Micro, Small, and Medium Enterprises (MSMEs) and the Financial Sector, specifically Participating Financial Institutions (PFIs). The proposed project's development objective is to provide long-term funding sources for banks to provide long-term credit to small and medium enterprises (MSMEs) to overcome the impact of the COVID-19 Pandemic. Negative impacts of the global COVID-19 pandemic are expected to exacerbate Lao PDR's weak fundamentals and lead to a deterioration in the macroeconomic situation, including the SME and Financial sectors. The proposed project aims to strengthen the capacity of financial institutions and MSMEs to sustain operations and recover from the COVID-19 emergency. The proposed project is to support the recovery and growth of privately-owned MSMEs by increasing the supply of long-term finance provided by commercial banks and by strengthening the capability of the Department of SME Promotion (DOSMEP) to formulate and implement public policies that promote access to finance for MSMEs and strengthen the banking sector to recover from the effects of the COVID-19 Pandemic.

The project includes three components: (i) Emergency and Recovery Line of Credit to MSMEs; (ii) Strengthening BOL Capacity to Supervise PCG Facility; (iii) Technical Assistance (TA) and Project Management which to notably support capacity building of MSMEs, PFIs, and DOSMEP. Particularly, a subcomponent of TA is to strengthen DOSMEP not only capabilities but also support DOSMEP to formulate and improve the SME development strategy, relevant legislation by engaging consultants. The proposed project will be managed by the Department of SME Promotion (DOSMEP). The required service is a part-time national consultant to be managed and selected by DOSMEP in accordance with the "World Bank Procurement Regulations for IPF Borrowers" dated July 2016, revised November 2017 and August 2018 edition.

In the period 2019-2021, DOSMEP in collaboration with the Asian Productivity Organization (APO) conducted a study on the National Productivity Master Plan of Lao PDR (NPMP), with a team of experts from Korea Development Institute (KDI) as the lead researcher. This document analyzed the current status of the country's productivity, expected future productivity targets as well as strategies and policy tools to achieve Lao national productivity goals. This includes plans for some relevant ministries, agencies, and other stakeholders in Lao PDR, to enhance Lao national productivity goals or targets for a ten-year timeframe, from FY2021 to FY2030. However, through joint consultation with the relevant departments, a review was carried out and it was found that the said document needed to be updated in some areas to reflect the proposals of the relevant authorities in the final development plan. The review will include, among other things, the expectations and relevance of the productivity promotion mechanism of Lao PDR, as proposed by the study in the first place.

As a result, under component 3 of the project, DOSMEP intends to recruit a qualified national consultant to support DOSMEP in reviewing and revising the National Productivity Master Plan to make it more appropriate as an official document, more comprehensible, and to be aligned to not only the 9th Five-Year National Socio-Economic Development Plan (2021-2025) but also to draw lessons from a regional context, especially best practices of neighboring countries. This Master Plan is also

expected to foster an opportunity for the Lao government and stakeholders across the relevant line ministries and agencies to jointly contribute to enhanced competitiveness of Lao businesses through higher productivity, the improved adoption of new technologies, and an enabling environment for innovative products and services for the market.

2. Objective of the Assignment

The selected consultant will work under the close supervision of DOSMEP and the task force to review and revise the study on the National Productivity Master Plan as proposed by the KDI expert team and revise the document based on the feedback relevant authorities as mentioned above. To this end, the consultant will coordinate with DOSMEP's focal point person to work with the relevant ministries to revise the document. The consultant will also review and check for relevance and appropriateness of the proposed policies and strategies for productivity enhancement. The revision will include revising and enhancing the existing contents and introducing emerging areas corresponding to development trends as relevant. The methodologies will consist of data collection, modifications based on revised data, if any, and consultations with the relevant stakeholders.

3. Scope of Work

The scope of work for the consultant shall include, but not limited to, the followings:

- The Consultant will review the overall contents and structure of the Master Plan, which covers the infrastructure development for productivity, productivity in leading sectors, and institutional leadership for national productivity.
- Restructure the existing version of the Master Plan into a shorter format so as to make it into a policy or development plan, instead of a study;
- Reviewing the proposed targets, directions, strategies, and measures to ensure that they are up to
 date, reflecting the needs and actions to be taken by concerned ministries and agencies, in line with
 development trends;
- Reviewing the best practices of some selected neighboring countries in terms of productivity enhancement, especially their institutional arrangements;
- Recommending an establishment of a more suitable National Productivity Promotion/Enhancement Coordinating Mechanism and an Institutional Implementation Arrangement (National Committee).
- Assist DOSMEP in organizing stakeholder meetings and consultations.
- Prepare necessary supporting documents when submitting the National Productivity Master Plan for approval by the government.
