Under the Component 3 of the project, DOSMEP intends to recruit an experienced National Consultant to support DOSMEP in amending the technical content of the Decree on SME Classification to be more practical in local and regional contexts.

#### 2. Objectives of the Assignment

The selected National Consultant will work closely with the Statistic and Planning Division and under the closed supervision of the Director General of DOSMEP in amending the Decree on SME Classification from technical aspects. The decree is expected to provide adequate details of the classifications and be practical in its applications for local and regional contexts, up to date and aligned with the amended Law, and contribute to MSME promotion especially access to support policies as required. In addition, develop guidelines to simplify the utilization of the decree in addressing different dimensions, including access to finance, access to supportive policies, and statistical purposes.

#### 3. Scope of Assignment

The consultant will review and analyze information related to policies, legislation, and conditions regarding MSME promotion and other relevant regulations regarding implementing the Decree on SME Classification. The relevant documents will be provided by DOSMEP. The consultant will also conduct a Regulatory Impact Assessment (RIA) on both the existing Decree and the amended Decree on SME classification, including its compliance with the Law on Making Legislation and the amended Law on MSME Promotion. Additionally, the consultant shall develop a guideline for using the decree to be simplified for the stakeholders in terms of enacting the decree. The amendment will include the following:

- Comprehensively enhancing the contents of the decree.
- Updating the conditions defining the categories of MSMEs.
- Developing a guideline on enacting the decree to be more practical and effectively used based on the objectives of concerned agencies.

Based on the above, the tasks for the consultant shall include, but are not limited to the followings:

- Review the structure, role and mandate of DOSMEP, MOIC and stakeholders on MSME promotion.
- A mapping of the existing legislation relevant to MSME promotion including Laws, Decrees, Agreements. The mapping will be accompanied by interviewing and consultation of relevant institutions and stakeholders such as Bank of Lao PDR, Ministry of Finance, Lao Chamber of Commerce and Industry, Department of Enterprise Registration and Management, Department of Industry and Handicraft, National Statistics Bureau, and Ministry of Agriculture and Forestry.
- Conduct research regarding the MSME classification, particularly in ASEAN and neighboring countries.

- Travel to provinces with DOSMEP to present the draft amended Decree in central and provincial consultation workshops and improve the decree according to the feedback received.
- Support DOSMEP to incorporate the feedback for endorsement by the government.
- Translated the endorsed amended decree into English.
